### Main Event

Squad Times: August 17<sup>th</sup> 9:30 AM and 2:00 PM

Entry Fee: \$135 per squad, \$125 if paid by August 1<sup>st</sup>, 2024

**\$200 (\$100 per squad) if prepaying for both squads before August 1<sup>st</sup>, 2024**

1. Bowlers will bowl four (4) games across eight (8) lanes.
2. Squad cut ratio will be 1:6. Extra spots in finals will be based on overall scores between the 2 squads.
3. 24 finalists will make match play based on 120 entries. 121-160 entries will result in 24 finalists in match play with additional pay spots being based on entries. 32 finalists will make match play based on 161-168 entries.
4. Byes will be determined based on entries.
5. Max 84 entries per squad.
6. Bowlers can cash twice if "cash twice" spots are available based entry threshold. Top 3 8-game total scores will be paid.
7. Finals will be two game total match play until the final four bowlers are determined.
8. Lanes will be reoiled for each squad and finals.
9. Pattern will be challenging.
10. All ties will be determined based on a 9<sup>th</sup> and 10<sup>th</sup> frame roll off.
11. Must prepay by early bird deadline to reserve qualifying spot.
12. Tournament director has final decision on any questions.
13. All USBC rules apply.
